However, as I was getting closer. I noticed that the taxi had make a turn into the carpark as such I had no time to react and the taxi collided to my bike.

I then flung onto the taxi front bonnet where a few passerby came over to carry me and placed me on the grass patch. At that point of time I was still conscious but I was not able to move due to the pain on my hips. Moments later, Ambulance came to the scene and I was conveyed to KTPH for further treatment and given 7 days MC.

Brief Details.

On 13/07/2020 at about 1945hrs, I was driving my taxi along Yishun Avenue 9 towards Yishun Avenue 6.

- 2) I had then wanted to turn right into Blk 317 Yishun Avenue 9 carpark and hence had checked for traffic coming from the opposite direction and established it to be clear. I then negotiated the turn.
- 3) As I was making the turn, a motorcycle (FBB3773Z) suddenly collided with the left front side of my taxi. The motorcyclist had then landed on my bonnet.
- 4) I immediately stopped and alighted my taxi. A few passerbys had assisted to carry the motorcyclist to the side of the road. An ambulance arrived shortly afterwards. I was unable to engage the motorcyclist as he was in a daze and was eventually conveyed to hospital.
- 5) I had observed that my taxi had suffered deep dents at the area of impact. The motorcycle was also observed to suffer damages to its front..
- 6) I wish to state that I had in car camera and the footage has been provided to the Traffic Police (who also arrived shortly thereafter) . That is all.
