

On 04/08/2020 at about 4.25pm, I was traveling along Tiong Bahru Road towards Leng Kee Road on my motorcycle bearing the registration number FBC2333L to send a food delivery order. As I was approaching Redhill Shell Petrol Kiosk; which was on my left, a car bearing the registration number SGT15U did not observe my travel as he tried to turn right from the opposite direction into the said petrol kiosk. I tried to avoid the collision, however it was too late. We collided and I landed on the bonnet of the car. I suffered abrasions on my right thigh and bruises on my left knee. The accident was also witnessed by another driver behind me. Subsequently, I was attended to by Traffic Police who assisted to call for ambulance. I was rendered medical aid on site, but did not wished to be conveyed thereafter. I had also exchanged particulars with the driver to facilitate our respective insurance claims. My wife then picked me up from the accident site and I sought further medical attention as I felt pain on my legs. I was then awarded 4 days of Medical Leave at Alexandra Hospital. I am lodging this report to facilitate my insurance claims. That is all.
