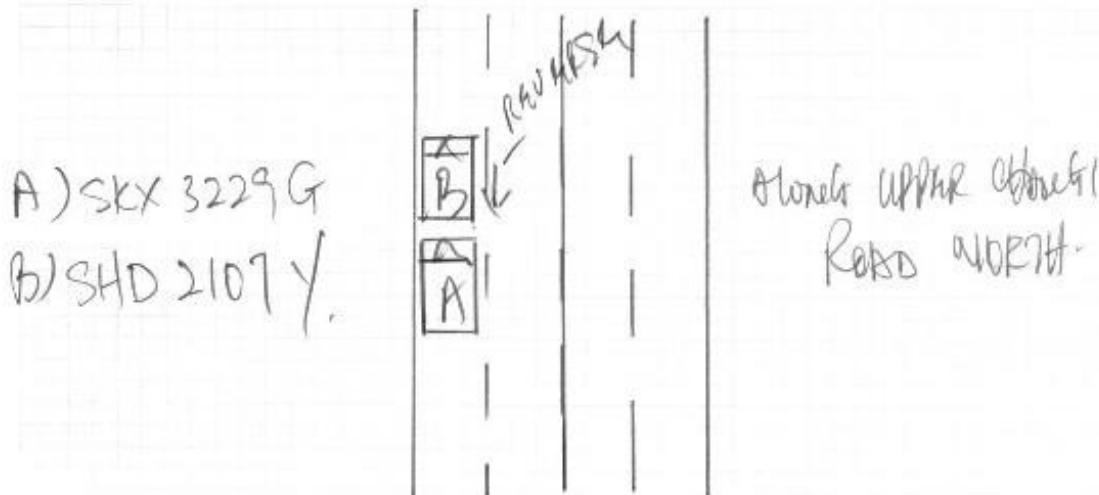

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 18 August 2020 at 1908hrs, I was driving my car SKX 3229 G along Upper Changi Road North to work. There is traffic jam along the street. While I was stationary in my car, a prime taxi SHD 2107 Y suddenly reversed and hit the front of my car. As a result, front bumper damaged.

Taxi Passenger Mr. Ng Kwok Hua, SXXXX8550 moved out to direct traffic, and informed taxi driver suffered from cardiac arrest and became unconscious. We carried him out to perform CPR + AED & ambulance brought driver away to the hospital.

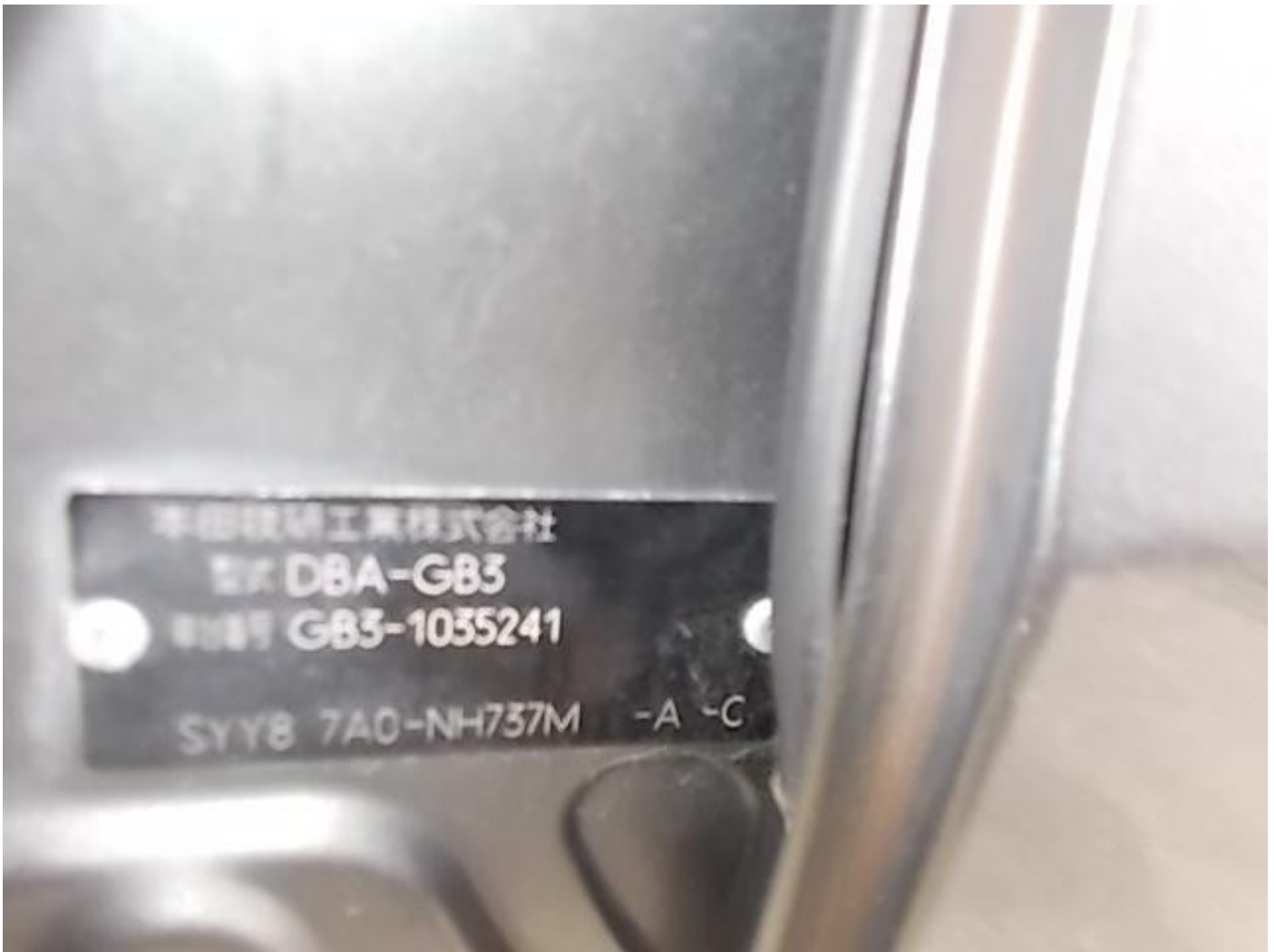

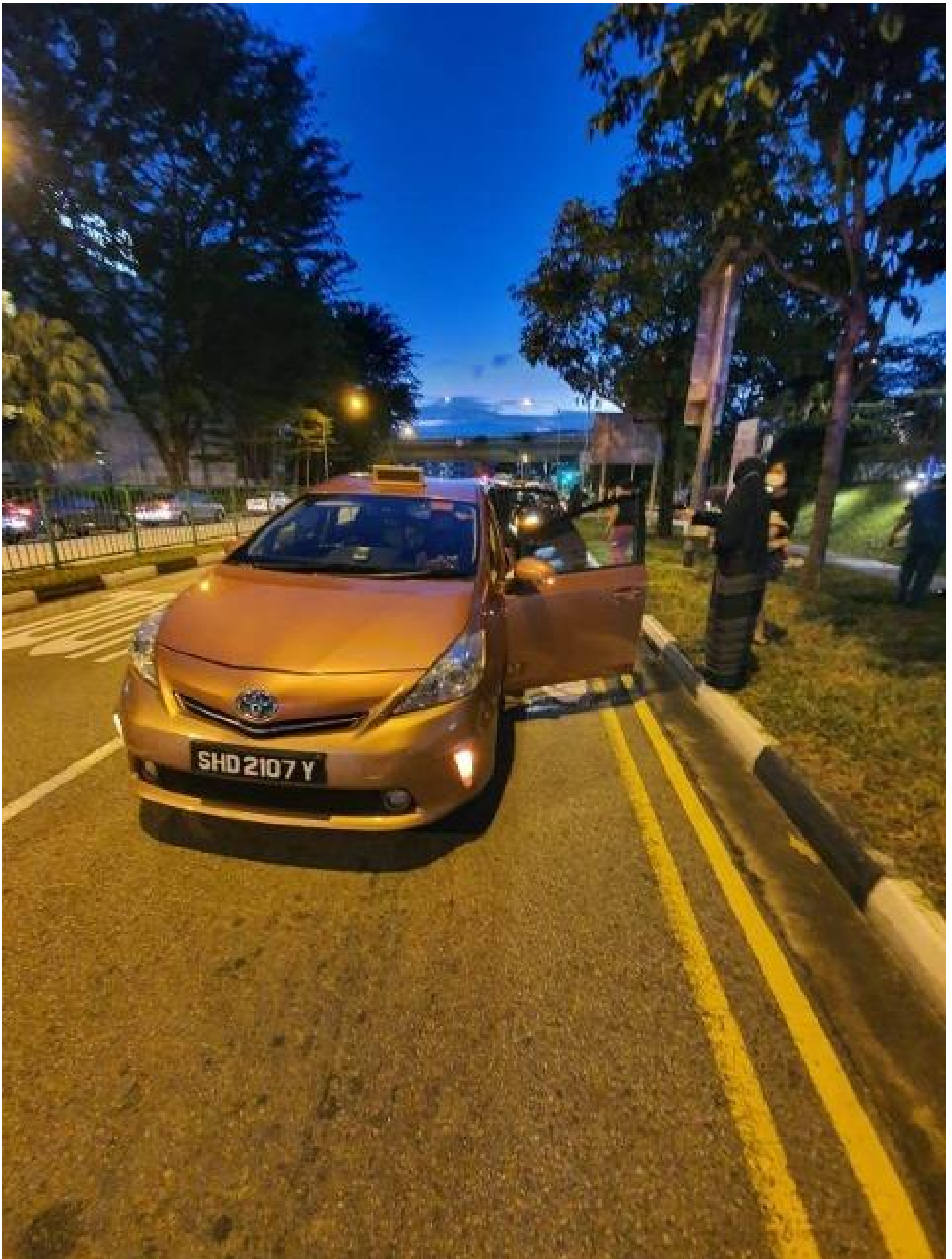
