




On Tuesday 18 Aug 2020, at or about 1610hrs, I, **S8040687H ONG YANZHU CINDY**, driver of **Blue Toyota Prius SKX128J**, was travelling westbound on Jurong Town Hall Road towards the Science Centre and was going to make a right turn into Jurong East Street 12.


The traffic light right-turning arrow was Green, indicating the right of way and I was the 3rd car in line behind 2nd car *Red Honda Vezel SLM6315S (S7586783B RAJKUMAR MANGHNANI)* and 1st car *Silver Mazda 3 SLP1298A (S1121231Z HOW HUNG HOCK)* to make the right turn from Jurong Town Hall Road into Jurong East Street 12.

From the opposite side of Jurong Town Hall Road (oncoming traffic), *Motorcycle FBP4630Y (MUHAMMAD MIRZA BIN KAMSANI S9823832H)* dashed through the red light on his side of the oncoming traffic.

The 1st car SLP1298A jammed his brakes in order to avoid a collision with Motorcycle FBP4630Y, resulting in 2nd car SLM6315S colliding into the rear of 1st car SLP1298A, and my car (3rd car SKX128J) colliding into the rear of 2nd car SLM6315S.

No one sustained any injuries.

Brief Details.

On 18 August 2020 at about 1610hrs, I was driving my car (SKX128J) along Jurong Town Hall road towards the science centre and was going to make a right turn into Jurong East Street 12.

The traffic light right turning arrow was green, indicating the right of way and I was the 3rd car in line behind 2nd car (Red Honda Vezel, SLM6315S) and 1st car (Silver Mazda 3, SLP1298A) to make the right turn from Jurong Town Hall Road into Jurong East Street 12.

From the opposite side of Jurong Town Hall Road (oncoming traffic), a motorcycle (FBP4630Y) dashed through the red light on his side of the oncoming traffic.

The 1st car (SLP1298A) jammed braked in order to avoid a collision with the motorcycle (FBP4630Y), resulting he 2nd car (SLM6315S) colliding into the rear of the 1st car (SLP1298A), and my car (SKX128J) colliding into the rear of the 2nd car (SLM6315S).

We then pulled over and exchanged particulars and left.

No one was injured. No government properties were damaged. No police and no ambulance were at scene.

I am lodging this report for record and insurance claims purposes.
