

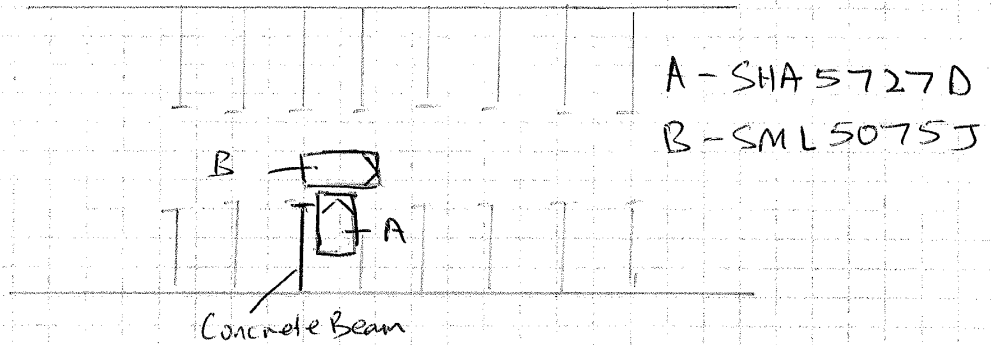

No pax in my taxi. No injury.


