ON STATED DATE, TIME AND LOCATION

I WAS TRAVELLING ALONG GREENWICH DRIVE TOWARDS TAMPINES. LOCATION WAS A SINGLE LANE, TWO WAY ROAD, DIVIDED BY CONTINUOUS WHITE LINE. I NOTICED THERE WAS A TAXI STATIONARY AHEAD WITHOUT HAZARD LIGHTS. AS SUCH I KEPT TO THE RIGHT OF THE LANE, STILL WITHIN THE SAME LANE. ABOUT ONE CAR LENGTH BEFORE REACHING THE TAXI, THE TAXI SUDDENLY MADE A U-TURN IN FRONT OF ME. I WAS NOT ABLE TO REACT IN TIME AND HE ENCROACHED INTO MY TRAVEL PATH, AND I COLLIDED ONTO THE RIGHT SIDE OF THE TAXI DRIVERS'S DOOR. DUE TO THE COLLISION I SUSTAINED MULTIPLE INJURIES AND CONVEYED TO CGH BY AN AMBULANCE. THERE WASN'T ANY MECHANICAL FAULTS TO MY MOTORCYCLE. THAT'S ALL.
