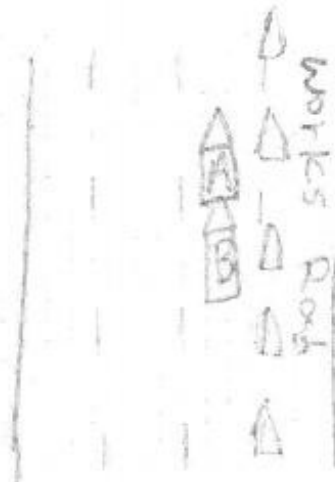
Sketch Plan #2
