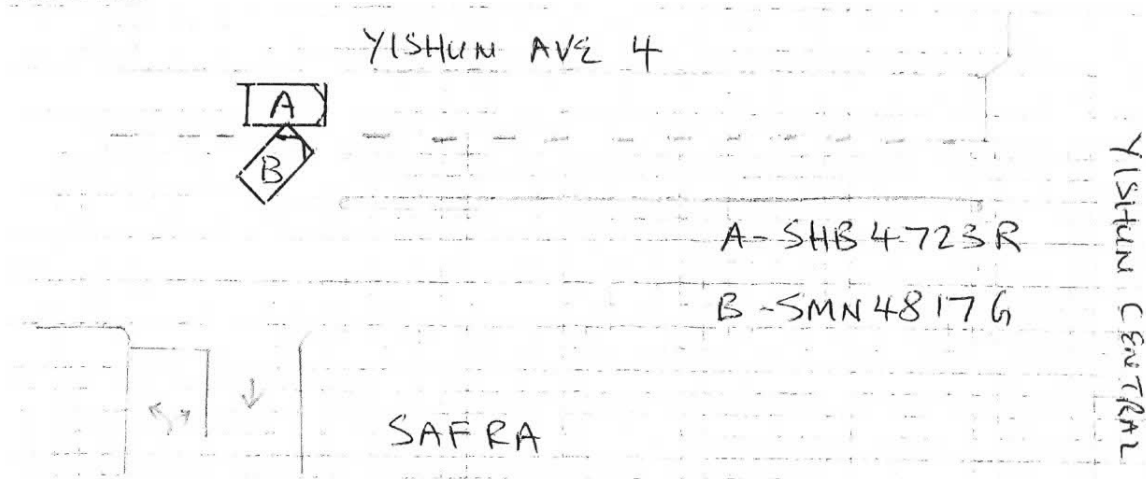

No injury at the time of accident.

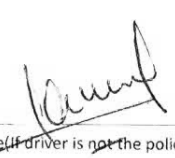
