Accident Sketch Plan



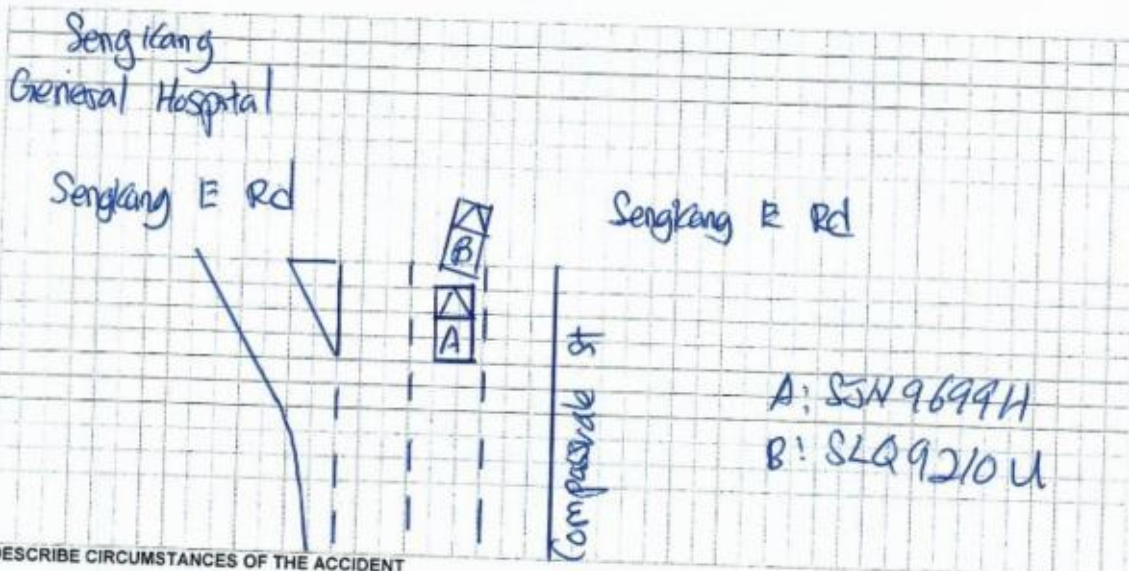


While the traffic light turning to amber light, car "B" suddenly jammed brake I could not stop in time and knocked the car seat portion.
