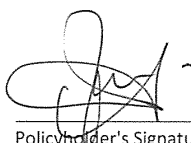

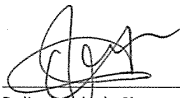

- SJJ 6918S then banged into SJP 9298X and SMK 5723C banged into SJJ 6918S

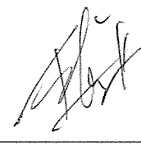
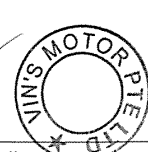
