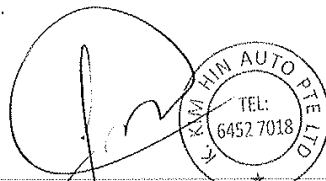

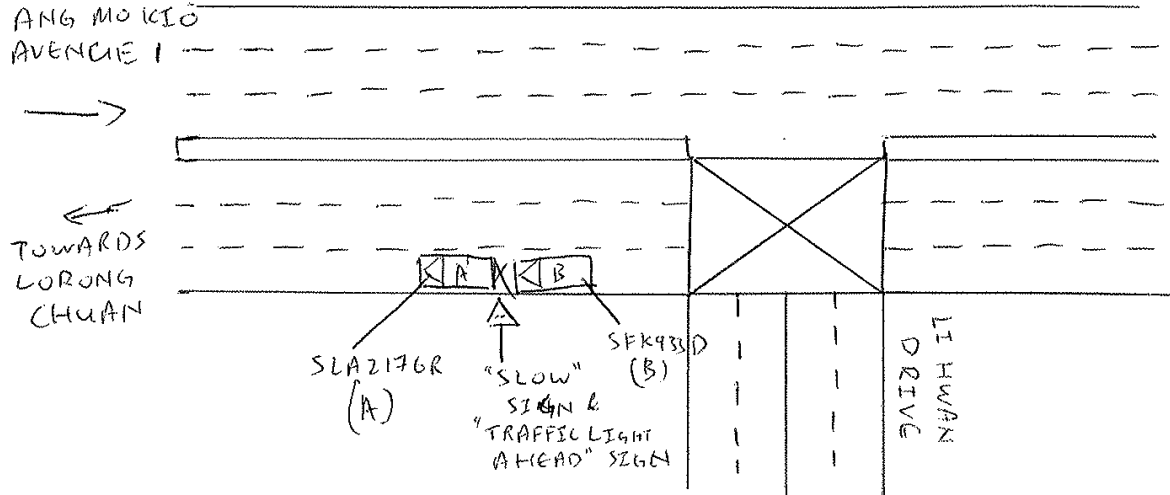

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving along Ang Mo Kio Avenue 1 towards Lorong Chuan. The road condition was dry, the weather was clear and visibility was fine. The date was 30 August 2020.

At about 1710 hrs, I was travelling at about 15 km/h as there was traffic in front of me. My vehicle, SLA2176R, was hit from the rear by vehicle, SFK933D.

After the accident, the driver of vehicle SEK933P, one YAP KIAN SENG, confessed to me, in the presence of MANAKA INDERDEV SAJNANI, that he was adjusting something in his car while driving. The accident also occurred in the vicinity of a "SLOW" and a "Traffic Light Ahead" signboards.

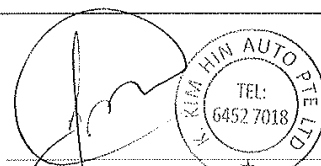
