

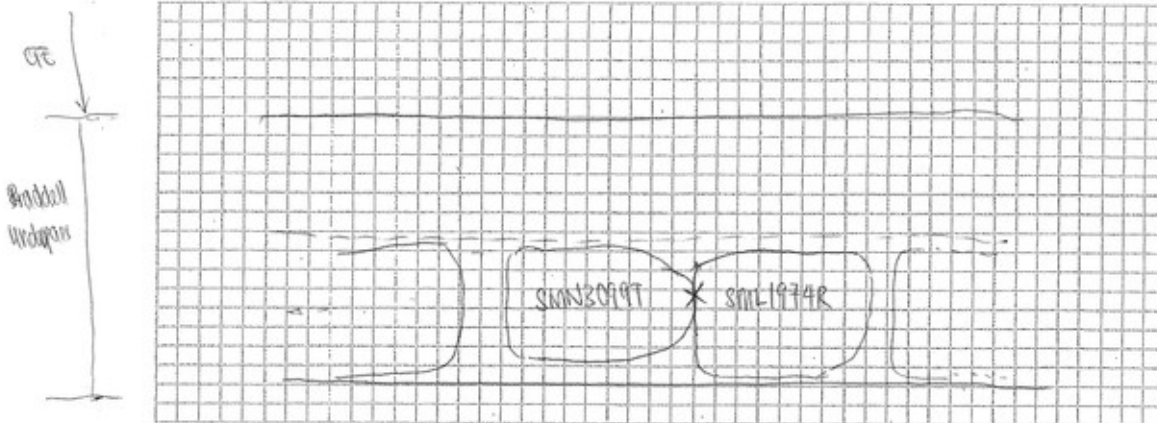

- Brief Details Of Accident -

On 29 August 2020, just before 12nn, I was involved in an accident near the underpass on Braddell Road just before the CTE, headed towards Bartley. The underpass is marked as "Braddell Underpass" on Google Maps. I was driving smoothly and traffic seemed brisk, leaving a reasonable amount of space between the driver and myself. car in front of me and myself. Upon seeing the brake lights of the car in front of me flash red, I slowed the car down gradually, thinking that he was slowing down too, especially since we were going downslope. I realised that he was losing speed rapidly, coming to a stop. So I jammed my brakes, but could not bring my vehicle to a stop quickly enough. Both drivers exited our cars and exchanged phone numbers and took photographs. The other driver pointed out that he had jammed his brakes also and narrowly avoided hitting the car in front of him, pointing to a jam ahead of him that was due to road works at the tunnel exit. I could not see this jam from within my car due to the size and height of his car. It was also unexpected because of the seemingly brisk traffic before this. After taking photographs and exchanging car details, we left to make our own reports unharmful. The front of our car collided with the left side of his rear bumper.

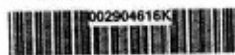

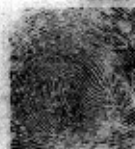
