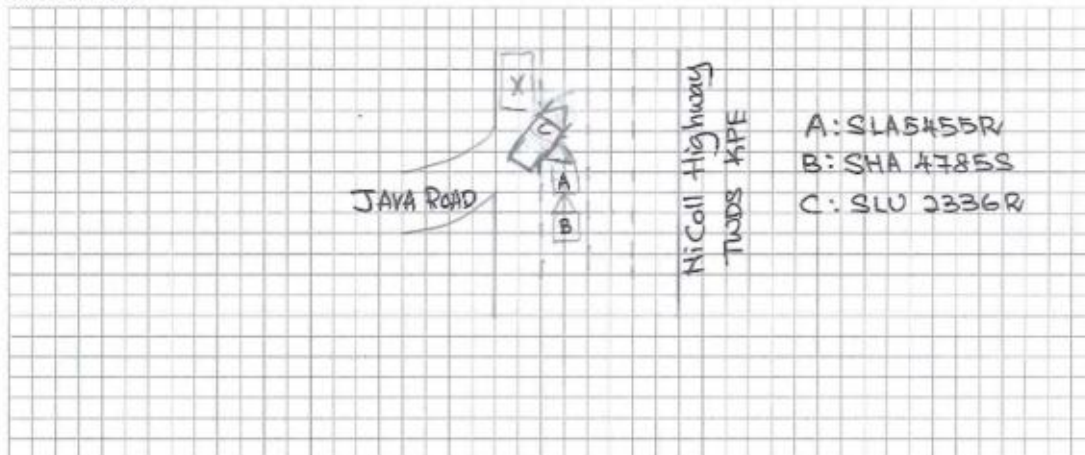

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 3 sept 2020 around 12.45pm, I was travelling along Hicoll Highway and on the 2nd lane at a three lane road after Java Road exit in my vehicle A SLA 5455R. As due to the roadwork on the left lane, I slow down and stop my vehicle due to vehicle C SLU 2336R who cut out abruptly despite my horn, when suddenly vehicle B SHA 4785S who was travelling behind me unable to stop in time and collided onto the rear of my vehicle which caused my vehicle to surge forward and collided onto vehicle C.
