


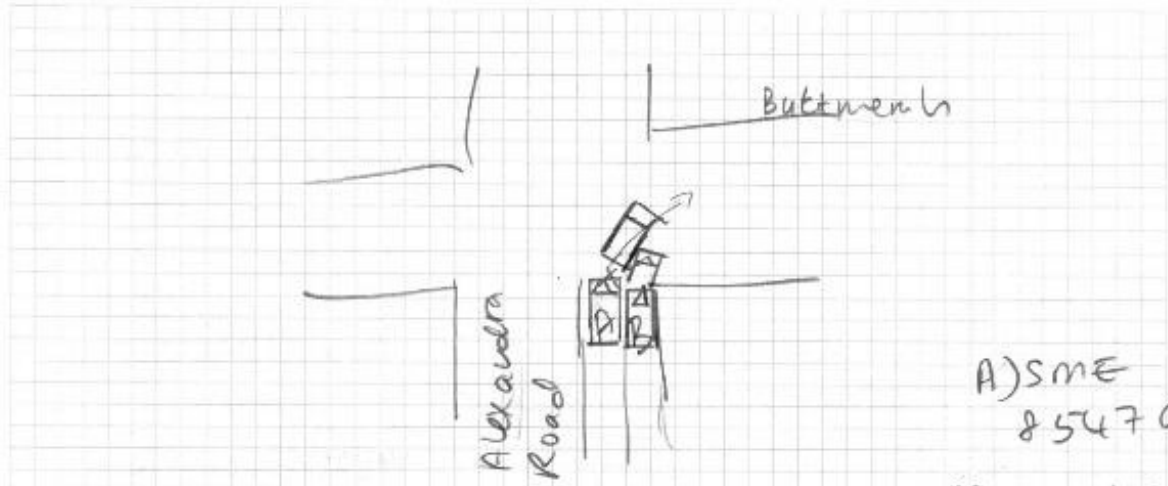

### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT
