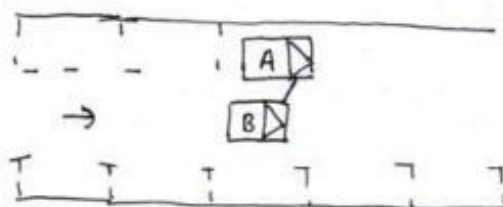

On the mentioned date and time was driving 5J17437G along 70 Desker Road.

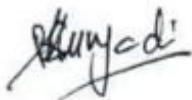
On the way I stop on Left Hand Side of the road to buy a drink.
