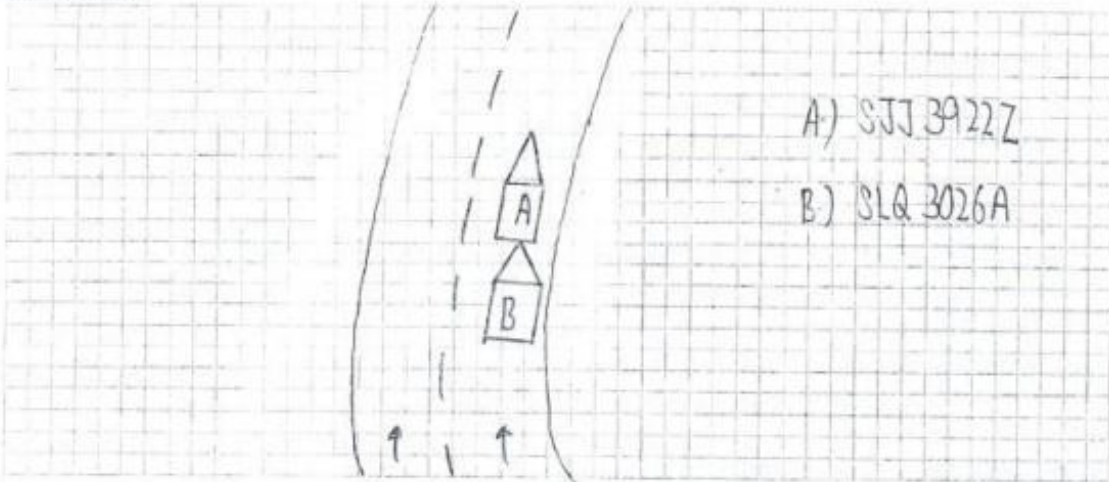

SKETCH PLAN

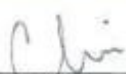

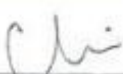
