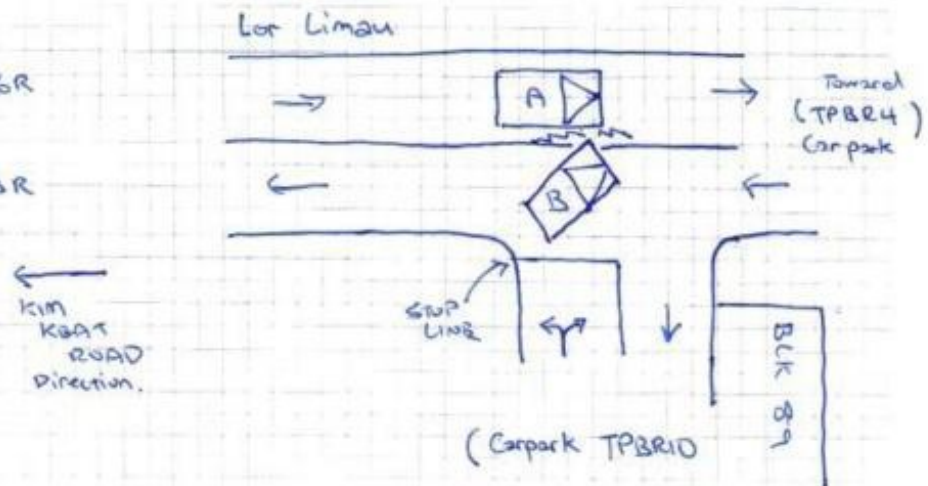

## DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

While driving straight ahead, somewhere at the intersection (T-Junction) of (Lor Limau / Kim Keat Road (Carpark TPBR10)) suddenly a vehicle fail to stop at the stop line, checking on on-going vehicle and turned out, which resulting causing collision into my vehicle, while I'm going straight ahead.
