## **Brief Details**

I was doing delivery under Deliveroo with my motorcycle(FBJ3577G). I was stuck at a red traffic light for pedestrian to cross. The pedestrian crossing is exactly in-front of Bishan Public Library. Upon traffic light turning green, I moved off and I am intending to go straight towards Bishan Street 13. Upon clearing pass the first T-junction after the pedestrian crossing, taxi driver(SHD4204L), who was in-front of me travelling the opposite side of his road decided to make a right turn early towards the taxi stand or the sheltered pedestrian crossing connected with Junction 8 Mall and Bishan Bus Interchange. My front bike collided with the front plate number of the taxi as he was making a early right turn and I was going straight. I was still conscious upon accident however I felt a sharp pain on my left leg that I was not able to walk normally. Was conveyed to Sengkang General Hospital, x-ray showed that I might had a hairline fracture on my knee area. Received 14 days hospital leave from the hospital.

I was not travelling more than 30km/h as I just moved off from the traffic light which is less than 10m before the t-junction where the accident took place.

It is dual carriage way with no curb or divider. Instead, it is the continuous white line that separate the dual carriage way.
