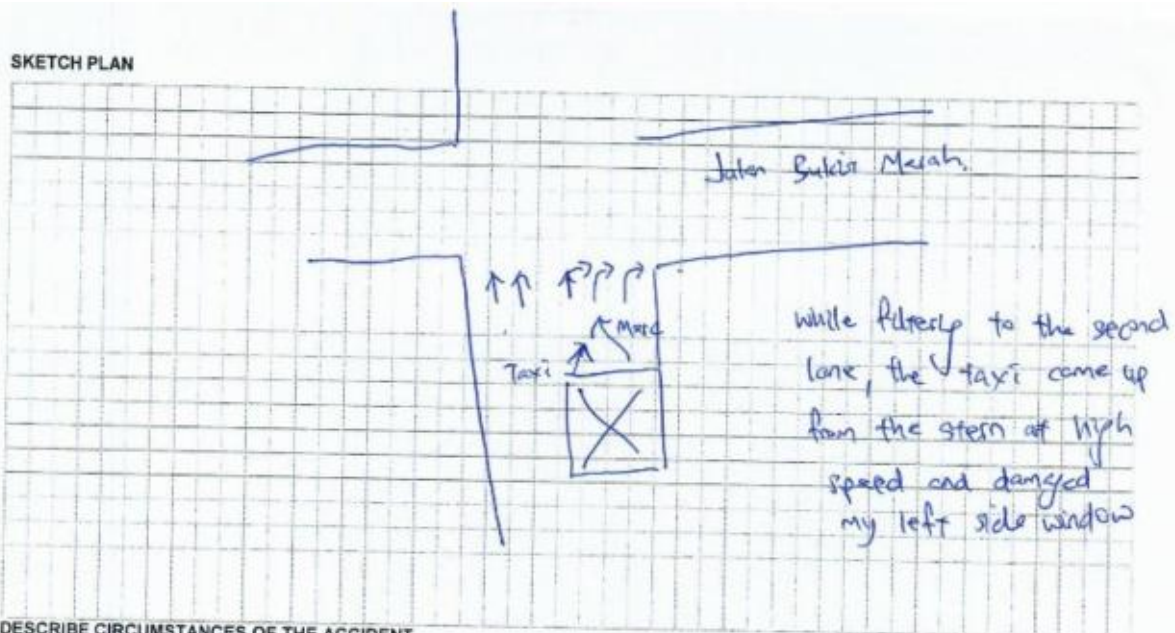

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At 139 hrs moving to the second lane at the junction, the taxi (SHA 52185) came up from the back and contacted my car.

Damage to my car - left hand mirror damage
 - visual damage to the left forward rim.
 - visual minor damage to the paint work on the door.

Damage to taxi - right forward tyre punctured
 - damage to his right hand mirror
 - no visual damage to the car paintwork.

I shifted my car to the second lane after the incident to prevent obstruction to the other traffic
