



SKETCH PLAN

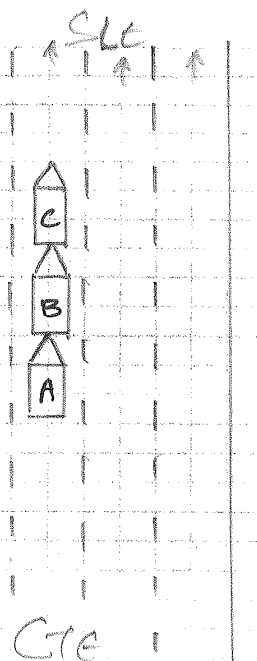
