RENTAL TERMS AND CONDITIONS

The Terms and conditions of Rental mentioned on all pages form an integral part of this Car Rental Contract. By signing this Contract, the Hirer confirms of having read the Terms and Conditions of Rental and of having his/her unconditional approval to the stipulations of the Terms and Conditions of Rental.

1. The Hirer acknowledges that the vehicle is the property of Mycar Leasing Pte Ltd (hereinafter referred to as the Owner) and that the vehicle is taken over in condition as stated in the Pre & Post Rental Checklist during the joint inspection between the Hirer and the Owner or the staff appointed by the Owner. The Hirer is under obligation to return the vehicle together with all tyres, tools accessories and equipment on the pre-arranged date – earlier if the Owner requests – in as good order and condition as the vehicle was when collected by the Hirer from the Owner.
2. In taking delivery of the vehicle, the Hirer shall be deemed to have satisfied himself/herself that it is in all respects road worthy and in a proper and safe condition. The Hirer and the Driver are liable for all loss and damages to the vehicle and its accessories during the rental. Hence it is important that the Hirer and/or the Driver perform joint pre- and post- rental inspections of the vehicle with the staff of the Owner and to take photographs as evidence whenever possible before handover and upon return of the vehicle. If the vehicle is delivered without pre-rental inspection or returned without a joint post-inspection (as in the case when the vehicle is towed back), the Hirer shall acknowledge any damage report made by the Owner and/or the appointed workshop of the Owner.
3. There shall NOT be any unauthorised addition to, alternation, replacement or substitution of any parts to or on the exterior and interior of the vehicle including rims, tires, bumpers, unapproved lightings, solar films, addition of curtains, accessories, etc without prior written approval from the Owner. The Hirer shall compensate the Owner if any of such changes are done to the vehicle. The amount for the compensation shall be determined by the Owner or the Owner's appointed motor workshop. The Hirer shall bear full responsibility if such changes to the vehicle resulted in fines and/or penalties from any Authorities, including Land Transport Authority and the Traffic Police Department.
4. The vehicle may only be driven by the Hirer (if Hirer is also the Driver) and the person who has been designated and authorised in this contract to drive. Both persons must produce current Singapore Driving Licences or valid driving licences of their own country or International Driving Licences. They must have at least two years of driving experience and must be at least 22 years of age.
5. No other person, other than the Hirer and the Driver listed, is allowed to drive the vehicle. The vehicle is not allowed to be rented to third person. Failure to comply will result in not getting insurance coverage in the event of any accident. The Owner will take legal action against the Hirer to recover any monetary damage suffered by the Owner and any claims for third parties damages and insurance.
6. The full rental cost is payable according to the Payment Terms and Conditions stated on the first page of this Rental Agreement. At the expiration of the rental contract, any additional charges which may have been incurred shall become due for immediate payment.
7. The Hirer shall make an appointment with the Owner or the Agent no less than 24 hours to make arrangement for the time and location for the return of the vehicle. The Hirer shall bring along his/her copy of this Car Rental Contract to do a joint Post Rental Inspection.
8. The deposit is refundable within 5 (five) working days to the Hirer in cheque, upon the return of the vehicle when the contract period has ended, all rents are paid in full, all fines from the respective authorities are cleared and the vehicle is returned in its original condition as at start of the contract. The Hirer must fulfil the contract period as well as all terms and conditions as stated in this contract. Failure of which, the deposit will be forfeited. Any amount which may stand at the Owner's credit on termination of this rental contract will be deducted from the refundable deposit.
9. Petrol is at the Hirer's expenses. The Hirer shall return the vehicle with at least the petrol level as per pre-rental inspection. If petrol level is below that level of pre-rental inspection when the vehicle is returned, the staff of the Owner will assist the Hirer to top up to that level and bill the Hirer for the amount of the petrol with \$20.00 service charge.
10. The Hirer and the Driver are allowed to perform commercial services such as Grab or other limousine services that are available in the market but they are subjected to the rules and regulations set by the respective companies that the Hirer and the Driver have taken up the job from. The Hirer and the driver have to comply with the laws and regulations of Singapore. (Strictly no street hail is allowed).
11. The Hirer and the Driver are required to keep the vehicle interior and exterior clean. Cleaning fee will be billed to the Hirer if professional cleaning service is engaged when the vehicle is returned with unacceptable cleanliness. Smoking, pets and durian are strictly not allowed in the vehicle at all times.
12. The Hirer and the Driver are advised to conduct regular checks, which include engine oil level and coolant level, on the vehicle. At all times the vehicle must be provided with sufficient oil, water and the prescribed tyre pressure. The vehicle must not be overloaded or passengers in excess of the motor vehicle licensed carrying capacity. When not in use the vehicle must be properly parked and locked. Tampering with the odometer is strictly prohibited. If the vehicle breakdown is due to the negligence of the Hirer or the Driver, the Hirer shall be liable for the repair costs and towing charges (if any). Rental for the downtime will still be chargeable in this case. Any damage to the vehicle, which includes punctured tires and faulty car battery, will have to be repaired or replaced and the cost for such repair or replacement will be bore entirely by the Hirer.

13. The vehicle is not allowed to be driven out of Singapore at all times without prior written consent from the Owner.
14. The Owner will cover the charges for normal maintenance of the vehicle. The Hirer shall call the authorised workshop to make an appointment for every 10,000km servicing and maintenance. 15. The Hirer and the driver MUST report all vehicle breakdowns & accidents to the Agent no later than 24 hours after the incident. A 24-hours Emergency Breakdown Service is provided free of charge from our authorised workshop. A replacement vehicle will be provided to the Hirer at the discretion of the Owner and subject to availability. In the unfortunate event that no replacement vehicle is available, rental will not be charged for the downtime period. (Please note that punctured tires, empty petrol tank, flat battery, loss of car key or key locked inside vehicle do not constitute a breakdown).

The Hirer and the Driver shall not without the prior consent of the Owner repair or give any instruction to repair the vehicle, or replace any parts of the vehicle thereof render by breakdown or accident.

16. The insurance excess is at S\$3,500. Own damage claim is S\$2000 and 3rd Party claim is S\$1500. In the unfortunate event of an accident, the Owner shall collect \$3,500, insurance excess from the Hirer regardless of which party is at fault. The amount will be returned to the Hirer if the fault lies with the other party after investigation by the relevant authorities. Please notify the Agent as soon as possible in the event of any accident and do not move the vehicle before photographs are taken for evidence purposes.

The Hirer or the Driver MUST NOT acknowledge or compound any claim either partially or in full without prior discussion with the Owner or the Agent. It is important that they secure the license number of all vehicles involved in the accident as well as the names, contact numbers and addresses of all parties involved and those of any witnesses. In any case, the local police authorities have to be informed.

The Hirer and the Driver are encouraged to take as many photographs as possible. Photograph evidences are very crucial in determining the result of the investigation. Photographs taken as evidence include the following:

- a) All parties' vehicles with vehicle number plates;
- b) Damages to all vehicles involved due to the accident;
- c) Street name or any landmarks to determine the location and position of the vehicles involved.

Conditions When Vehicle Not Cover By Insurance

The Owner's insurance policy does not apply when the driver is younger than 22 years old or older than 65 years old. It also does not cover when the driver does not have a minimum 2 years driving experience.

17. The Hirer shall indemnify the Owner against all loss suffered by the Owner, including loss resulting from inability to use the vehicle or lease at the same rental rate, in consequence of the destruction, loss or theft of, or damages to the vehicle prior to the vehicle being returned to the Owner.


18. The Hirer and the Driver are solely liable for all traffic and parking offences for the vehicle in this contract from the date and time handed over to the Hirer till it is returned to the Owner. In the event of any breach thereof, the Hirer shall pay all fines and penalties which may be incurred and shall also answer all Police and Traffic Court Summonses, Notices and Inquires in connection therewith.

19. The Hirer and the Driver shall not drive the vehicle whilst under the influence of alcohol and drug. If this condition is breached resulting in accident, both the Hirer and the Driver shall be fully responsible for all damages.

20. The Hirer and the Driver have been warned that they are NOT allowed to use the vehicle for any illegal dealings or activities, like smuggling and transportation of drugs and contraband items, ferry of illegal immigrants and etc. If they are caught, they will be fully liable and the Owner reserves the rights to take legal actions against them.

In the event of the vehicle being seized, confiscated or forfeited due to any criminal acts, the Hirer shall indemnify the Owner to the value of the vehicle or replace with another vehicle of equal value and shall bear all costs and expenses to which the Owner may occur or be pitted or exposed.

21. The person signing this Contract assumes full responsibility, along with the firm, person or organisation in whose name he/she might sign. In the event of any disputes arising out of or in connection with this Contract, the parties hereto hereby agree and submit to the jurisdiction of the Courts of the Republic of Singapore.
