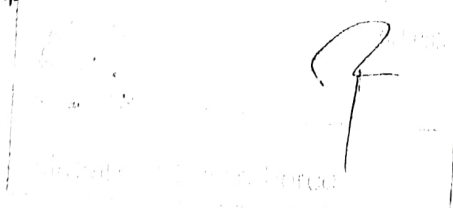
Brief details.
