I WAS DRIVING ON THE 2ND LEFT MOST LANE ALONG ANG MO KIO AVE 3 TOWARDS ANG MO KIO AVE 8(MRT STATION) ON 18 SEP 2020 AT ABOUT 9:50AM. THERE WAS A WHITE CAR TRAVELLING IN FRONT OF ME. WHEN SUDDENLY, THE BUS ON THE LEFT MOST LANE (BUS LANE) SWERVED RIGHT TOWARDS THE 2ND LEFT MOST LANE. THE WHITE CAR (SGS 4927 S) APPLIED BRAKES TO AVOID THE BUS. I ALSO APPLIED EMERGENCY BRAKES BUT MY CAR COULD NOT STOPPED IN TIME AND HIT THE REAR OF THE WHITE CAR. THERE WERE NO INJURIES INVOLVED. THE DRIVER DROVE OFF AFTER WE EXCHANGED PARTICULARS.

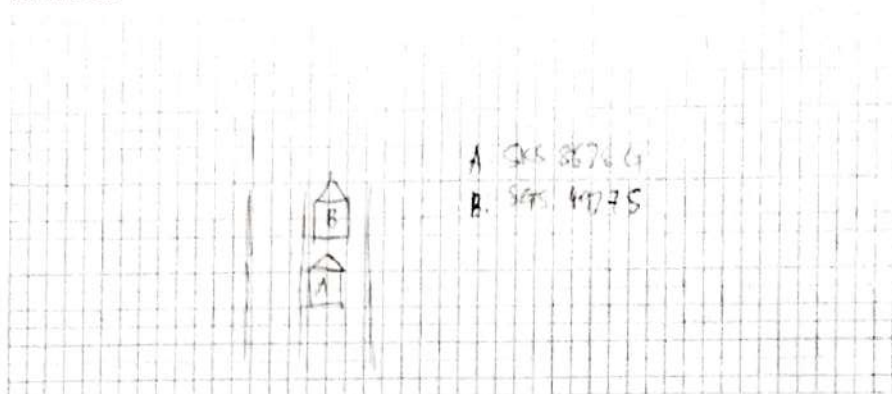
