

SKETCH PLAN





NOTICE OF REPORTING

This is to confirm that Lim Hong Liang, S8010951B has reported to the Police a traffic accident which occurred on 21/09/2020 at about 1430hrs along PIE towards Changi. I was travelling along PIE when out of a sudden the vehicle in front of me applied brake. I then applied brake to prevent colliding thus a van that was behind of me collided into my rear and another car behind collided into the second car, causing a chain collision. The traffic accident does not consist of the below following criteria:
