

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 28/8/2020, 11:15am, I was parked my vehicle SKW913P in Saint Paul church carpark lot. My wife and myself were waiting in the stationary car while my helper picked up my daughters from Kindergarten.

SKJ3667Z reversed into the parking lot on my right side. I sounded the horn when he was reversing too close to my side, however he didn't stop and ended colliding to my car, right front bumper, causing paint scraping off. We alighted and showed him the paint transfer evidence and took photos, and video of the damage.

Driver's spouse thinks I am making a big fuss, told them we are proceeding to report accident and claim insurance on their vehicle. He was Driver was upset about it and told me to claim and send him workshop quotation before any repair.
