Brief Details.

On the 21/09/2020, at around 1931hrs, I was driving along the first lane of Pan Island Expressway (PIE) near the exit towards Central Expressway (Seletar Expressway / Tampines Expressway) and Kallang River. Due to heavy traffic, my vehicle (SLP4566G) was moving very slowly to close up the gap between the vehicle in front of mine. Suddenly, I felt an impact coming from the rear of my vehicle. I alighted immediately and realised that the white lorry (YP327C) collided into the rear of my vehicle. The rear of my vehicle was seriously damaged but there was no damage caused to the lorry. Subsequently, we exchanged our particulars and we left the scene.

No government property, pedestrian, cyclist or foreign vehicle was involved in the accident.

As my left shoulder felt strained, I went to Sengkang General Hospital for a medical check up and was given 5 days of medical leave. The doctor suspected that I might be suffering internal bleeding in my left abdomen.

I am lodging this report for investigation purpose.

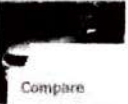
