



I could not brake in time and the vehicle(SLG5124) collided onto me head on. Airbag was being deployed in my car, I was not sure if the other vehicle airbag was being deployed. I immediately call Grab services and was told to call 999 and I did. After that I call my car rental company to inform of the situation. I made a check on my passenger and he said he was injured. I alighted my vehicle and check on the other party. Police and Ambulance came shortly after and made a check on us, there was no conveyance by the ambulance.
