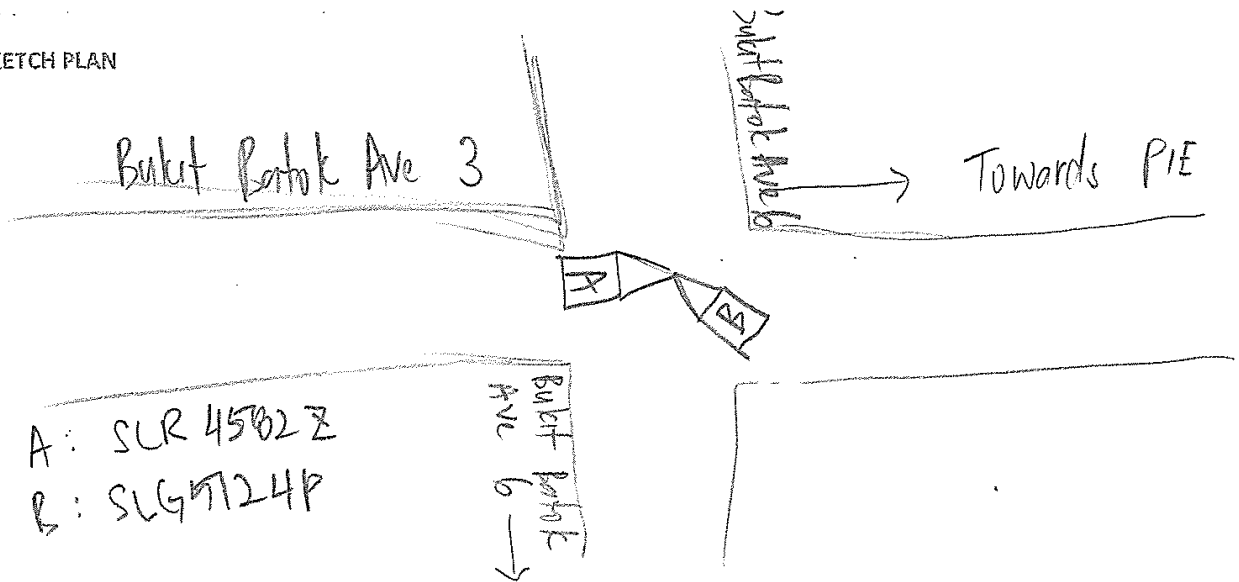

Brief Details.

On 19/09/2020 I was driving along Bukit Batok Ave 3 towards PIE(City) on the lane 1. I notice that the traffic light was green and it was my right of way. I continue to drive as per usual and having a passenger on board. When my vehicle was at the X- junction of Bukit Batok Ave 3 X Bukit Batok Ave 6 , there was a white vehicle(SLG5124P) from the opposite lane trying to make a right turn into Bukit Batok Ave 6. I could remember the traffic light for the other party was suppose to be red as the traffic light on my side was in my favour. I could not brake in time and the vehicle(SLG5124) collided onto me head on. Airbag was being deployed in my car , I was not sure if the other vehicle airbag was being deployed. I immediately call Grab services and was told to call 999 and I did. After that I call my car rental company to inform of the situation. I made a check on my passenger and he said he was injured. I alighted my vehicle and check on the other party. Police and Ambulance came shortly after and made a check on us , there was no conveyance by the ambulance.






