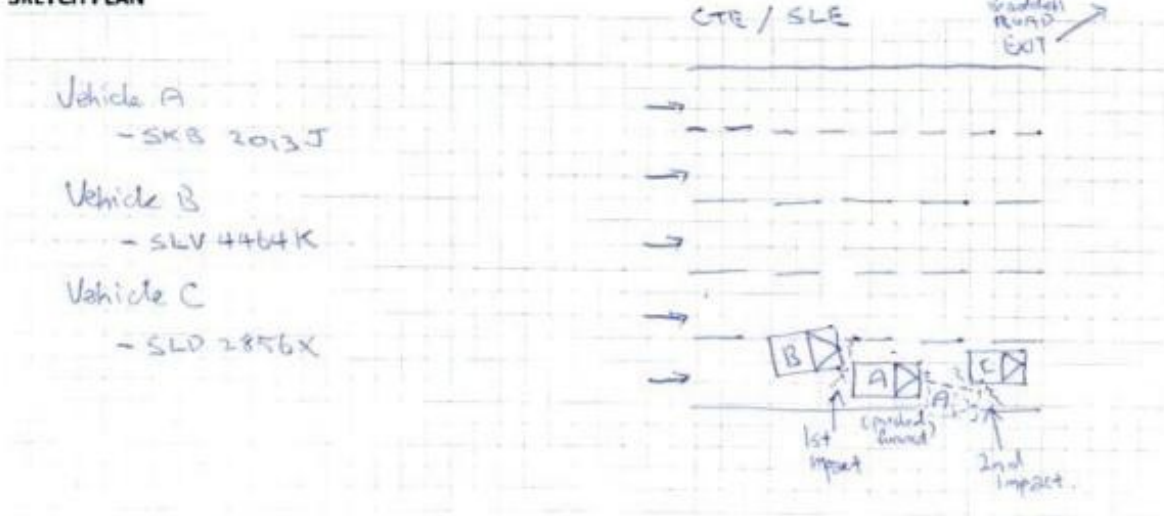

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving along CTE towards SLE. I was on the extreme right lane.

While driving straight ahead, the vehicle in front was travelling slow and so I was too closely following while keeping a safety distance with the car ahead. Which suddenly after a few seconds, I felt a great impact from the rear of my vehicle. Due to the heavy impact I was pushed forward. I tried to avoid hitting onto the vehicle in front of me so I tried to serve to the right, but nevertheless of my effort the front left portion of my vehicle hit onto the (vehicle right rear portion) in front of me.

Alighted from my vehicle and realised it was a vehicle (SLV 4464 K) collided to the left rear of my vehicle and causes me to hit onto the vehicle in front of me.

After the accident, Traffic police division officer was at the scene. And memory card of my in-car camera was retrieved by the officers.
