Brief Details.

AFTER TURNING LEFT FROM JLN BESAR INTO SYED ALWI ROAD, I(FBE89S) WAS TRAVELLING STRAIGHT TOWARDS JLN SULTAN WHEN SUDDENLY THERE WAS A CAR (SGL322A) ON THE OPPOSITE LANE(TOWARDS JLN SULTAN) TRYING TO MAKE A ILLEGAL 3 POINT TURN INTO MY LANE. AS THERE WERE ROWS OF CAR ON THE OPPOSITE LANE QUEUEING TO TURN LEFT INTO JLN BESAR ROAD, OUR VIEW WAS BEING BLOCKED FROM NOTICING EACH OTHER. BY THE TIME I SAW THE MENTIONED CAR, IT WAS ALREADY VERY NEAR TO ME AND HAD I NOT SWERVED LEFT IN ORDER TO AVOID THE CAR, I WOULD HAVE HIT THE FRONT LEFT OF THE CAR AND FLEW OFF. ALSO THERE WAS A ROW OF CARS PARKING ON MY LEFT, SO THE AMOUNT OF SPACE FOR ME TO SWERVE LEFT IS LIMITED AND AS A RESULT I SKIDDED AND LANDED ON THE ROAD. I WAS THEN CONVEYED TO RAFFLES HOSPITAL BY THE AMBULANCE AND WAS SUBSEQUENTLY GIVEN 5 DAYS MC. MY MOTORCYCLE ALSO SEEMS TO HAVE SERIOUS DAMAGE.
