Brief Details.

On 29/09/2020, at about 1430hrs, I had stopped on the road along Sengkang East Way, next to Blk 121E Sengkang East Way, after the zebra crossing as I was waiting for oncoming traffic along Sengkang East Drive to clear before making a left turn to proceed to Punggol. I was stationary when all of a sudden, a taxi (SHA392T) collided into me from behind. The impact caused my inner thighs to slide forward and slam into the front part of my motorcycle but my motorcycle did not fall over. As I was in pain, I called the ambulance. The paramedics checked on me and informed the Traffic Police Officer that I did not sustain any serious injuries. As such, I did not have to be conveyed to the hospital. The Traffic Police Officer then advised me to proceed to a nearby clinic. Shortly after the incident, I began to feel pain in my back. I made my way to Faith Healthcare and the doctor prescribed me with three days of MC.

The taxi driver provided me with his particulars. His name is Kong Khu (NRIC: S1465331G).
