SKETCH PLAN

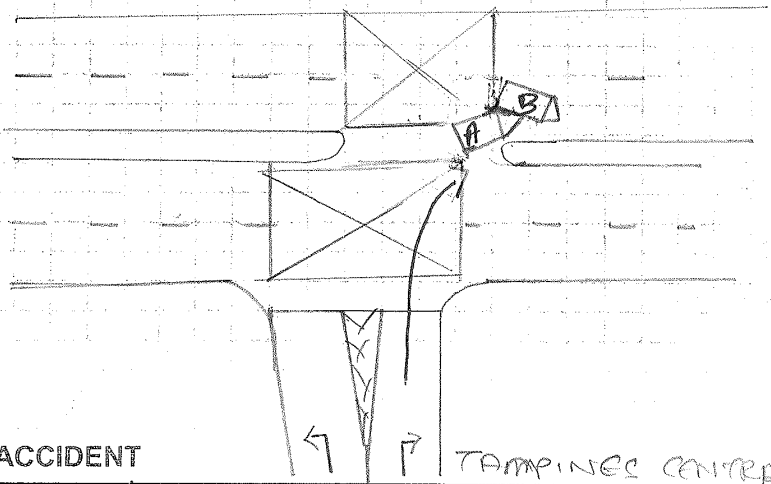
