I WAS AT THE FILTER LANE OF ANG MO KIO AVE 1 TO UPPER THOMSON RD, SECOND CAR TO MOVE OFF, WITH THE CAR SLZ 937 T IN FRONT OF ME. SEEING THAT THE MAIN ROAD WAS CLEAR, I TURNED MY HEAD TO CHECK BLIND SPOT WHILE MOVING OFF. DIDN'T NOTICE THAT THE CAR IN FRONT OF ME HADN'T DRIVEN OUT. BUMPED INTO SLZ 937 T BUT DID STEP ON MY BREAK IMMEDIATELY. BOTH THE DRIVER AND I GOT DOWN TO CHECK THE CARS. AND WE BOTH TOOK SOME PICTURES. AS NO ONE WAS HURT AND DAMAGES WERE MINIMAL, WE DECIDED NOT TO BLOCK THE TRAFFIC BEHIND. WE MOVED OUR CARS TO THE SIDE OF THE ROAD ON UPPER THOMSON RD AND EXCHANGED PARTICULARS. 
