**Brief Details.** 

SINGAPORE 530357 On 01/10/2020 at about 2130hrs,I was driving my wife's car SJY6287A along Sengkang East Way. I wanted to enter the filter lane and to enter into Sengkang East Read. I stopped behind a car SKT7388A at the filter lane. The car started moving off. I moved forward and checked for oncoming vehicle. While I was checking suddenly there was an impact on my car. I stopped the car and saw that I had collided into the car in front.

I alighted from the vehicle and we exchanged particulars. I checked my car there was not much damage. I checked with the other driver and offered to pay for his damages. The other driver refused and said that he wanted to do insurance claims. We drove away. I reported it to my insurance company for reporting purposes.

On 09/10/2020, I opened the letterbox and saw that there was a letter from traffic police asking to lodge an accident report. I have an in car camera which shows that the car deliberately stopped causing an accident. Clearly there was no vehicle anywhere near the merging lane.
