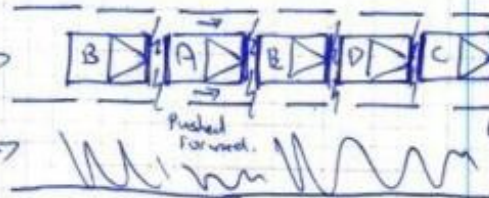

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

I was driving along TRG towards CTE/SLE direction, I was on the middle lane. (2nd lane)

while driving straight ahead, while somewhere before Jln Kaigu exit, due to the vehicle in front brake to complete stop, I too applied brake to complete stop.

Suddenly after a few seconds I felt a great impact from the rear of my vehicle, the impact was so great that pushed me forward and hit onto the vehicle in front of me.

Alighted from my vehicle and realized it was a vehicle with licence plate (SHA 3260X) collided to the rear of my vehicle and pushed me forward and hit onto the vehicle in front of me. It was a chain collision involving of 5 vehicles.
