Circumstances of Accident

WSVC20001541 Accident_Description I went to view 25A Cotswold CI for purchase. My car was parked along Cotswold CI on the opposite right side of their gate. The lady seller (Shirley) was in a hurry to fetch his son she drove out of the house and turn right. The front left of her car hit the right side rear of my car near the rear wheel. All of us heard a loud sound while standing inside her gate waiting for her to leave the house before we could leave. Even her house helper was there waiting to close the gate after us. We couldn't see my car because her car (Jaguar SUV white. believe to be F-pace) was blocking the view. She didn't stopped to check the damage. She reversed partially back into her gate (I thought she was going to come down to check the damage) but turn the other way (turn left) and sped away from the scene. We were all shocked. Her house agent (Daniel) was the first followed my my husband (Koh Chye Hock) to go check on the damage. we found scratches on the location right side rear of my vehicle and some white powdery marking on the rear right wheel as well as 1 white powdery spot on the rear side skirt of my vehicle. Daniel called shirley's husband who was in the house and later went into the house. But the husband (Tim) didn't come down to see the damage. Through Daniel we were asked where do we want to send our car for repair and I answer my dealer's service center (Wearnes) and I was told that the husband said he will settle direct with my workshop.



must be because the white powder was still fresh. I examined carefully and saw that some part of the wheel has the same white powdery matter attached near the right rear rim and one spot of white powder on the skirting below the damage spot. Everyone took some pictures with their phone. Her house maid came out of the gate and stood beside the dustbins and she asked if her Mam had hit our car? I said yes. She smiled and said her Mam always hit here and there. She pointed to her dustbin area and her gate. Then, Cassandra asked Danilo if he could go get Tim to come down to see the damage. Meanwhile, Daniel was texting. He must have received reply from Tim as he asked Cassandra to ask me whether I wish to bring it to their workshop or mine? My answer was, Mine. This is a 2-month old car and we always bring back to Land Rover Service Center. Land Rover is a reputable, reliable company that will not inflate prices. I also said it should be easier for both of us because he must be a customer with them too as they were having the same made of car. I also mentioned that I will send my car in and let Land Rover Service Center give him the quotation directly, so I don't have to be involved. Daniel was still texting and my husband and Cassandra again urged Daniel to get Tim to come down. Daniel went back into the house. We waited. Several minutes later, Daniel came out and said to Cassandra just proceed to send the car to Land Rover and Tim would settle with them. We took Tim's words in good faith and didn't second guess that he would go back on his words. Before we parted, Cassandra asked if we were going to make a police report. We said in front of Daniel that since Tim has agreed to pay with the damage, there is not necessary to do so. We took his words for it. We were all saying and in agreement that there are so many of us witnessing the incident and Tim has agreed to deal directly with Land Rover, my husband and I decided to leave. We went one round of the estate because we couldn't find the exit road and when we drove passed the house, Cassandra and Daniel were still talking. We waved to them and left.

We drove the car to Land Rover immediately so they can see the damage first hand and give us a quotation to forward to Tim. While we were on the way to the Land Rover Service Center at Leng Kee Road, we had some conversation with Cassandra, we told her where we were heading. We told her to find out Tim's and Shirley's name and contact number from Daniel so we can pass on to Land Rover to deal with them directly. However, it seems like she was having difficulty obtaining them from Daniel. Our guess was that Daniel, being an agent would not want to give the owner's details to us directly, which if that's the case, is understandable. My husband then told Cassandra to pass his mobile number to the agent to forward to Tim. Cassandra later send us a lead search of 75A Gosswood Cl and found the name of Owner, which we believe was Tim. Shirley's name was not in there. When we arrived at Land Rover, we told my regular service agent to see if they could trace this customer and send the quote to him direct. I have provided his other car number, address and the name we found from land search to the service center. Land Rover did an assessment and told us they would provide us a quotation the next day for repair and a replacement car during the 2 days the car has to be in the workshop. We told Land Rover that they do not need to quote Tim the same car I have as it might be very costly, just quote him any car that is available as long as we have a replacement car for the 2 days. We left Land Rover Service Center.

Just as we were heading home to rest, we received Whatsapp messages from Cassandra saying that now Daniel refused to be part of it, Shirley was very angry and said "Whatever Tim agrees is not my

Initially, Shirley's husband named Tim informed their agent that he will settle with the Land rover service centre. However at a later time of the day, I was told by my agent that Shirley does not wish to take any responsibility.

On 23/09/2020, we had a viewing with intention to purchase a house, 25A Cotswold Close Singapore 359653 at 3pm together with our house agent Cassandra and seller's agent Daniel. We arrived on a mid about 3.15pm as I was not feeling well earlier. I parked my vehicle along Cotswold Close, opposite the gate of 25A Cotswold Close away towards the right side of its gate. We proceeded to view the house with the housing agents. One of the house's maid was following us and cased by all the way. When we viewed the master bedroom, we met the house's owner, Tim and Shirley. It must have been around 15:25, when we were at the living room near the main door of the house, Shirley appeared behind me and excused herself to pick up a pair of off white sandals and told me she was rushing. She then proceeded to the car porch and started her car. We finished viewing the house and all of us including her maid were in the car porch waiting for her car to leave the house before we could move out. (The car porch was packed with 2 other cars parked inside. One black Range Rover Vogue SE95P and a blue Audi sports car SM13652P). Shirley proceed to move her white Jaguar SUV (Believed to be F-pace) out of the gate and turned right. All of us heard a loud bang sound and she stopped the car immediately. We were all asking each other "did she hit my car?" We were not able to see my car from where we were because her car was big and blocked the entire view of my parked car outside. Shirley reversed her car immediately, partially back into her car porch. At that juncture, I was expecting her to come down of her car to check the damage. Instead, she immediately turned left and drove off. Before I could compose myself, she fled off. I was not able to take down her car plate number. I was still shock standing at the same spot looking at my car from where I was, then house agent Daniel and my husband were the first to get to my car to check the damage. Followed by Cassandra and me. I was behind Daniel. Daniel first spotted some white powder with deep scratches at the right rear of the car, near the rear wheel. He used his fingers to rub off some of the white powder and he asked me if that was the spot. I answered it
