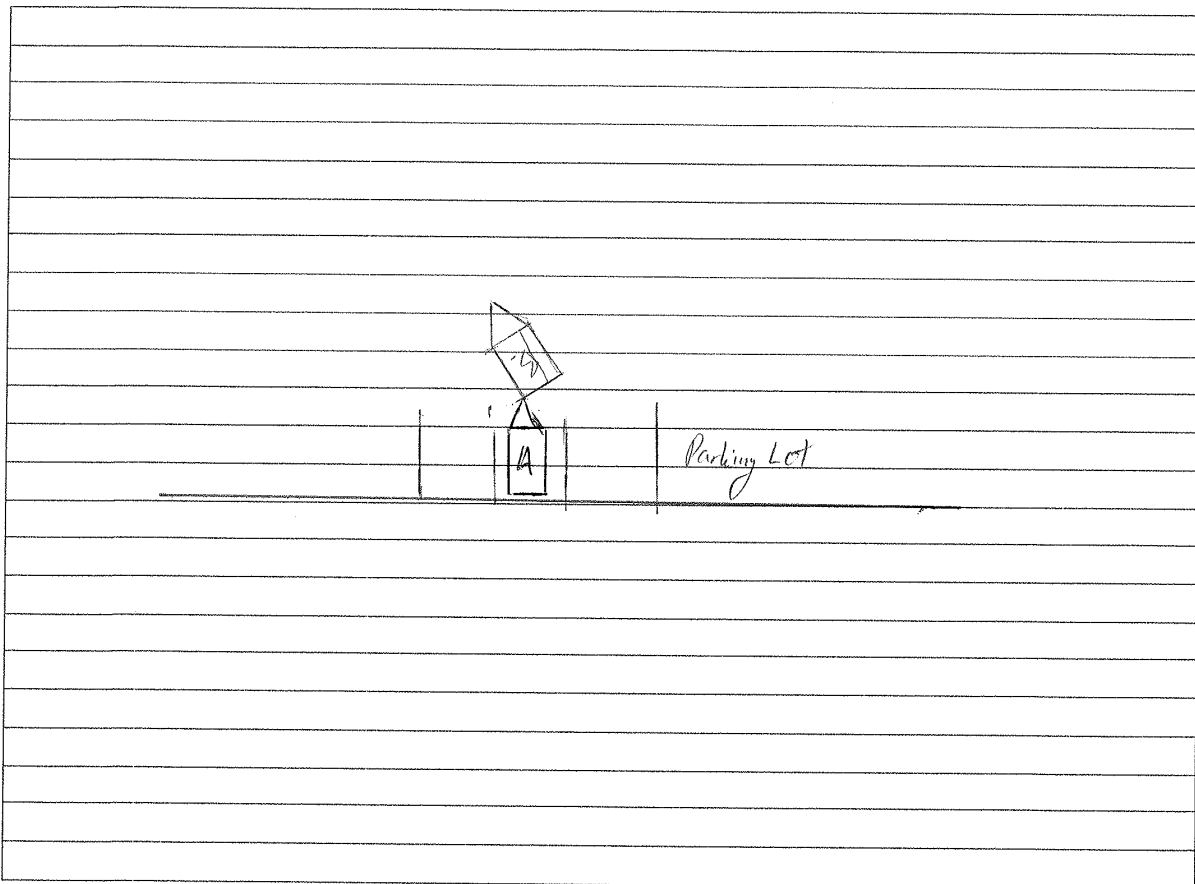

SKETCH PLAN



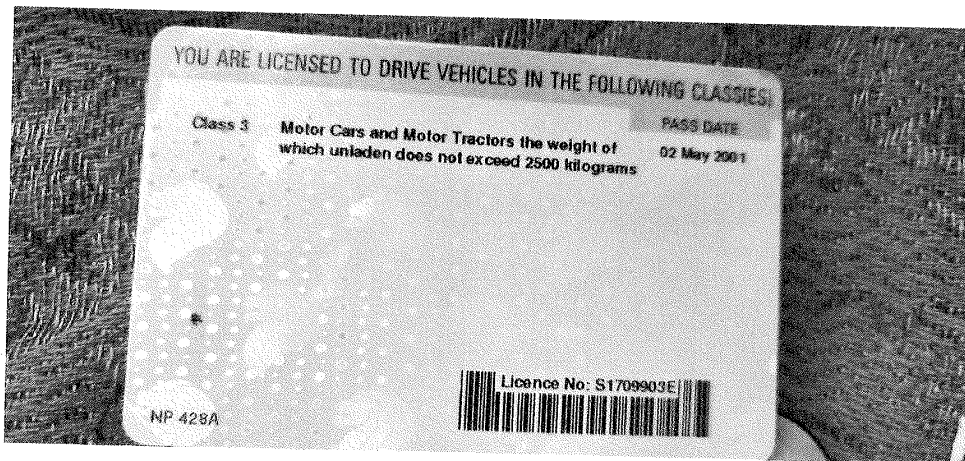
