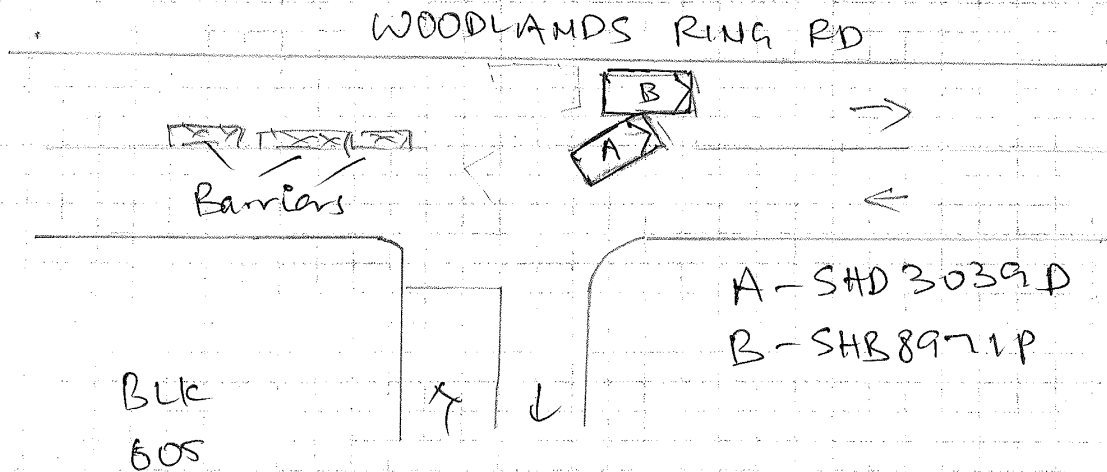

On 06.10.2020, at about 0645hrs, I stopped my Comfort taxi, SHD3039D,

at the carpark exit from Blk 605 to check for traffic on the main road, Woodlands Ring Rd.

There was a road construction on the left side and there were plastic barriers along the centre divider, blocking the view.

When traffic was clear, I slowly proceeded to turn right into Woodlands Ring Rd.

As my taxi was almost straight, a fast moving Premier taxi, B, came from my left and collided with my taxi.
