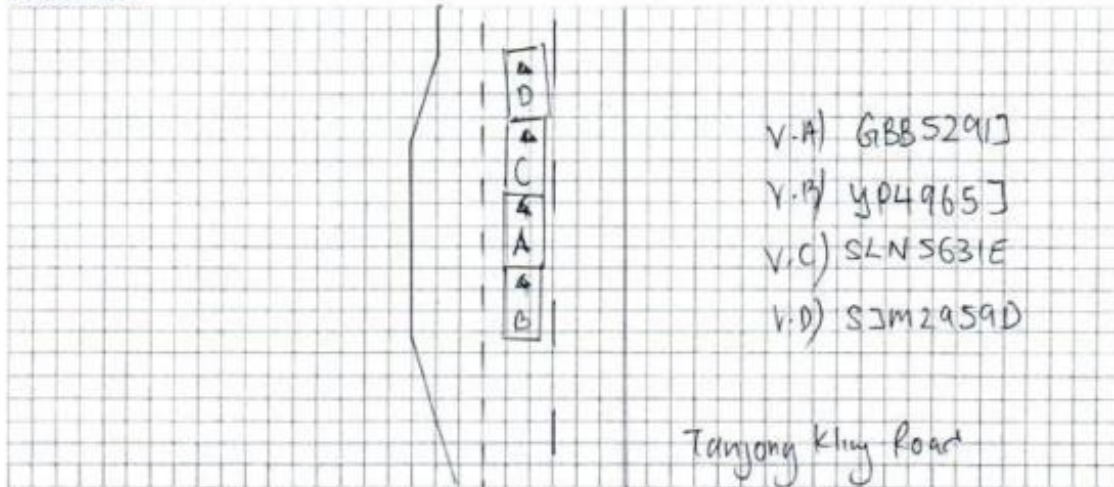

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On the stated date and time, I vehicle 'A' was travelling on the stated venue. I was traveling straight in my lane, the front vehicle jammed brake, upon seeing I brake my vehicle too. I managed to stop in time, however the very next second I felt a huge impact on my vehicle. The impact pushes my vehicle forward and collided against SLN5631E. Shortly I got out and realised I was involved in a 4 car chain collision. Vehicle D' SJM2959D filtered in our lane and brake, vehicle 'B' brake, followed by mine and vehicle 'D' hit my stationary car and pushes my vehicle in front.

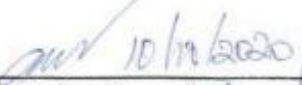
