

ACCIDENT INVOLVING SMU 8190S(AIG) AND SDV 50S AT/ALONG NEAR BOTANICAL GARDEN ON 10/10/2020

We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third party claim against your policy.

We have received a claim from SDV 50S against your insurance policy.

Based on the accident report and accident scenario, we are of the view that we do not have a good defense toward the claim submitted by SDV50S. Your vehicle was turning out from minor road and collided with third party who was on main road. Under Motor Accident Guide, vehicle turning from a minor road should stop at the "stop line" to give way to traffic approaching from both sides/directions of the major road. Therefore, we shall proceed to negotiate for an amicable settlement of the third party claim at best to avoid further litigation, which would escalate to even more cost.

Should you however wish to further discuss on the matter prior to our negotiations and settlement, please contact us within 7 days from the date of this letter.
