May I seek your assistance to perform a detailed mechanical inspection of the 4 vehicles below on an urgent basis, please.

a. Case IAFP-IB-20201007 - Mechanical Inspection of Lorry, YQ1397M (TP/IP/23759/2020)

On 24 May 2020 at 5.32 a.m., an accident took place between a lorry and a pedestrian along open space carpark of Choa Chu Kang Avenue 4 near to Block 417. Further investigation revealed that driver of the lorry, was driving under the influence of alcohol. DPP's direction for lorry to be inspected to eliminate mechanical fault or any possible defence raised by the defendant.

b. Case IAFP-IB-20201007 - Mechanical Inspection of Motorcar, SMS6055Z (TP/IP/41703/2020)

On the 24 September 2020 (Thursday) sometime around 12.57 p.m., the driver moved off from a junction due to red light and collided into a traffic police officer in front of him who was attending to an incident. However, 2 days later on 26 September 2020 (Sunday), the driver of the said car was reported dead. Due to the sensitivity of the case, CIO GIT has requested for the motor car to be sent for inspection.

c. Case IAFP-IB-20201007 - Mechanical Inspection of Motorcar, SJH2723Z (TP/IP/42901/2020)

On 1 October 2020 at 9.36 a.m., an accident took place between a motorcar and a pedestrian along Killiney Road. Further investigation revealed that driver of the lorry, was driving under the influence of alcohol. Motorcar required to be inspected to eliminate mechanical faults and for completeness of investigations.

d. Case IAFP-IB-20201007 - Mechanical Inspection of Lorry with Crane, XD6513S (TP/IP/43023/2020)

On 02 October 2020 at about 1710 hrs, the driver of the motor lorry had forgotten to lower down the crane and subsequently drove the motor lorry. The crane collided onto a 4.5m shelter. Kindly inspect on whether there was any mechanical fault on the crane.
