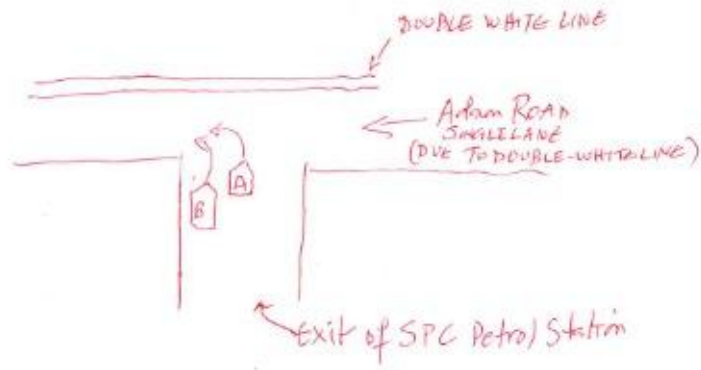

Accident Report on Oct 2, 2020 at exit of SPC petrol station turning into Adam Road

I was waiting to turn left onto Adam Road from the SPC petrol station. My vehicle was SGG6235-E

I was at the exit to the petrol station first

The other vehicle SGX6309L then came from behind me and tried to overtake me from the left.

Adam Road has only one lane to turn into because of a double white line. So I should go first because I was the first to arrive at the exit of the petrol station. But the other vehicle tried to overtake from the left.

I side scraped the other vehicle on the front right side with my tire as it tried to overtake me when I was already turning. As a result, the other vehicle got some damage on the front part of the right side.

The other driver complained that this was a two lane turning. How can that be when there is only one lane to turn into? Surely the vehicle that was at the exit first should turn first. Also the other vehicle should not try to overtake from the left
