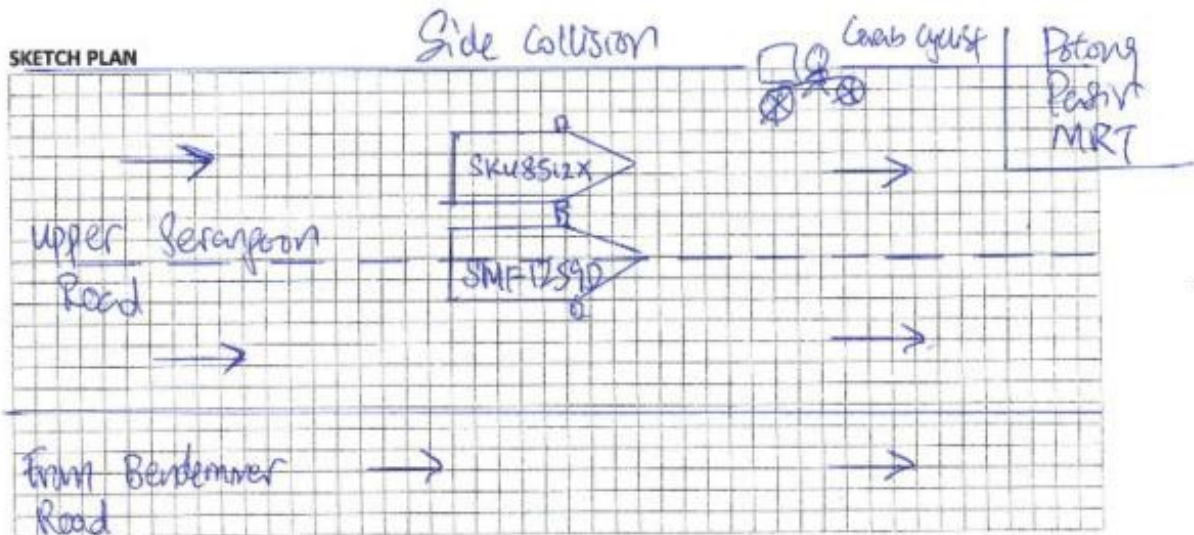

### Brief Details.

I exited CTE towards upper Serangoon road and was travelling along the 2 lane road near Potong Pasir mrt station. It was about 10.45pm and the traffic was moderate to heavy. I was ferrying my wife and 2.5years daughter going home at Kovan.

I noticed a grab cyclist riding near the kerb and a few Drivers infront of me over took him. I was cautious and kept a distance from the rider as he was riding abit out. I kept to my left lane and suddenly I heard a loud bang onto my car. I saw something's flew off from my side windscreen and a dark blue Mazda drove past me hurriedly. Both my wife and daughter was shocked and terrified. I slowly moved towards the car as it was a red light at a traffic junction shortly infront. I signalled to the driver intending to ask him to stop after the traffic junction. When the light turned green. He sped off in unsteady manner and filtered all the way to the right of a 4 lane road to the next junction. I tried to keep up and again stopped beside him signalling to him to wind down his windscreen so that I can talk to him. He did not so I signalled again to ask him to stop his car. He continued driving and turned into the following junction into Bidadari estate. I followed and high beam him. He finally stop his car and I stopped behind him and asked my wife to stay in car.

I took some photos of the damaged side mirrors and requested for his particulars. He refused to provide me and claimed that he was not sure what has happened. During the engagement, I smelt alcohol and suspected that he may have drank. I told him it's dangerous the way he has driven and advised him it was not safe for him to continue driving. As it's getting late and I worried for my family safety, I told him I will report police and we can claim insurance for the damages accordingly. He apologised and pleaded not to report. He said he stayed at the estate and wanted to go home. I told him to stay put and wait for TP to assess his situation. I waited until a TP car came abt 15 mins later.
