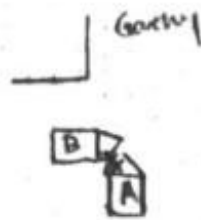

SKETCH PLAN



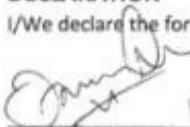
