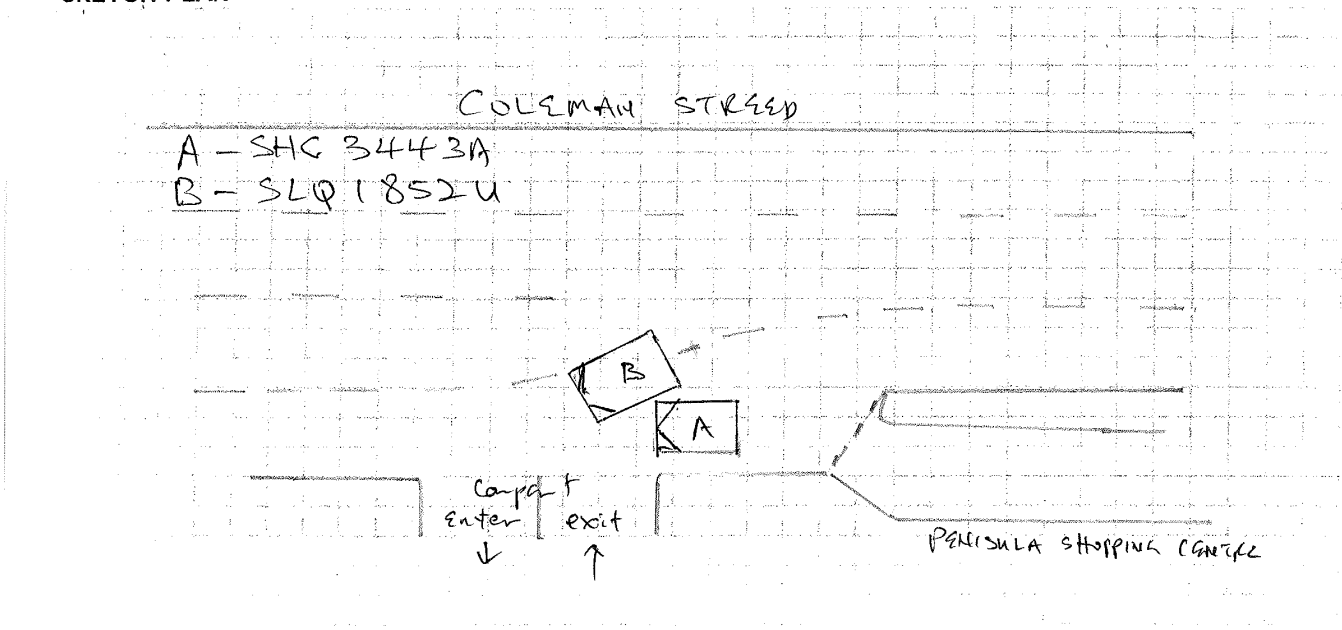

Describe Circumstances of the Accident.

On 18.10.2020, at about 1150hrs, I was driving my Comfort taxi, SHC3443A, on the left

lane along Coleman St with 2 female pax.

Weather was clear and light traffic.

Somewhere near the Peninsula Shopping Centre carpark entrance, a fast moving private

car, B, came from my right, cut into my lane and its left rear door area hit my taxi
