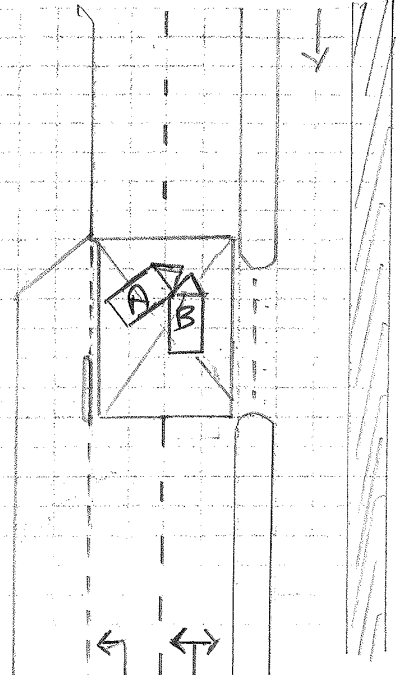
SKETCH PLAN
