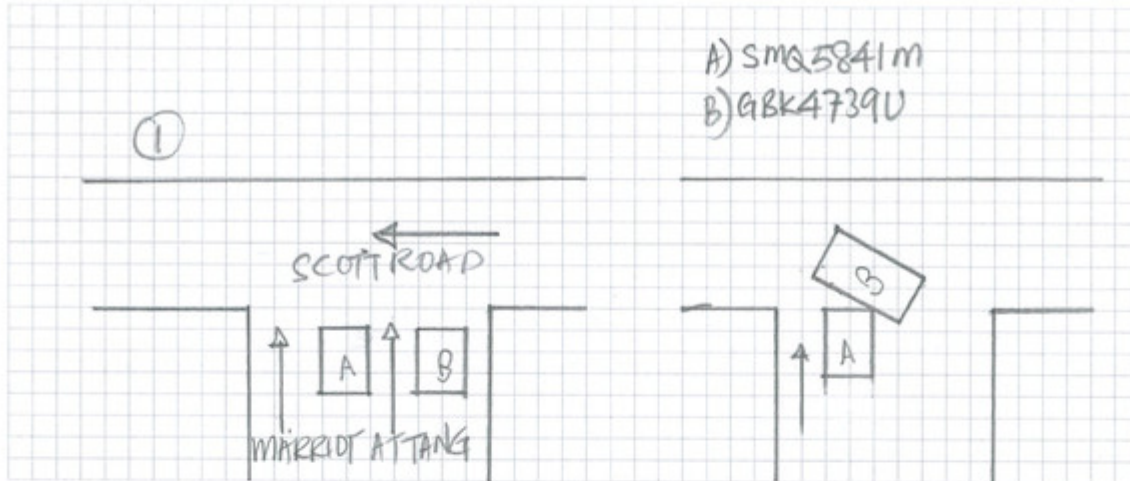

<p>ON THE 21/10/2020 AT 1454 HRS, I WAS DRIVING ABOUT TO TURN OUT OF MARRIOTT TANG PLAZA ON TO SCOTT ROAD. THERE IS A VAN AT THE RIGHT SIDE OF THE LANE. I WAS AT THE LEFT LANE AND KEEP IT LOOK OUT FOR ANY VEHICLE TO TRAVEL TO THE MAIN ROAD. HOWEVER, THE VAN WAS ON THE RIGHT LANE AND THE VEHICLE JUST OVERWHELMED INTO MY LANE.
