Hi Jaslin,

I had a talk with Jessie from Efficient Motor & Engineering Pte Ltd.

After speaking with her, I am of the opine that liability is not in our favor, but Efficient Motor & Engineering Pte Ltd is open to settling the case at between 50-100%, quantum to be decided.

I would need your help to speak with Insured driver SMQ 5841 M on this matter.

Firstly, find out what his Third Party claim status is, has it been resolved or liability has been confirmed by the other party.

Explain to him that the Third Party has chosen to litigate the matter, which means that in the event if we lose the case (which is high possibility), we will have to foot the legal fees and on top have to recover a Section 2 excess from him at \$2,140.00 (inclu 7% gst).

However, should he withdraw the Third Party claim and proceed to claim OD insurance, under the policy condition, he is able to get a 50% waiver of his Section 1 excess, which amounts to around \$963.00 (inclu of 7 % gst).

#### 216. In-car Camera Excess Waiver

If You have installed an in-car camera in Your Vehicle, the Excess applicable to Part B Section 1 of this Policy will be waived if You are not at fault for the accident and the accident is covered under this Policy.

If you are at fault for the accident and the accident is covered under this Policy, the Excess applicable to Part B Section 1 of this Policy will be reduced by 50%.

The following conditions apply to both a full and partial waiver of the Excess as set out above:-

- · Your Vehicle is involved in the accident with another vehicle

Now do explain to him, that we as his insurer is trying to mitigate the cost of the claim. The Third party is intending to let the matter slide, if we are able to withdraw SMQ 5841 M Third Party claim. If we are to contest, base on the scene photo provided by the Third Party, there is a high possibility we will lose the case as it has been observed that SMQ 5831 M is not at the stop line.
