

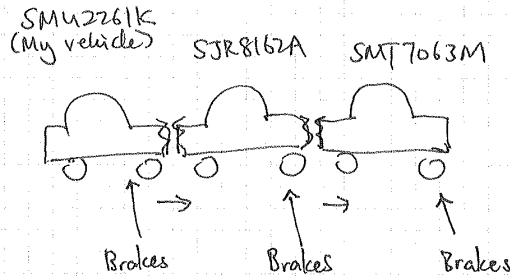

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT


On 21 Oct 2020, at about 6:30pm, Aloysious Teoh Zhu kai was driving my vehicle (SMU 2261K) along TPE, which I had given him permission to do so. Near the TPE - KPE intersection, Aloysious was driving on the rightmost lane, at about 80km/h, when the vehicle 2 cars in front of him, SMT7063M, hit the brakes hard. Subsequently, the vehicle in front of Aloysious, SJR8162A also hit the brakes hard, and collided into SMT7063M. Aloysious then jammed his brakes, and collided into SJR8162A. No vehicle collided into the rear of Aloysious. The crash resulted in no injuries across all 3 vehicles, but resulted in significant damage to the front (bumper, bonnet, side fenders) of my vehicle (SMU 2261K), as well as the rear bumper of the middle vehicle (SJR 8162A). There was a slight dent in the rear of SMT7063M, and front of SJR8162A.


After the accident, all 3 drivers alighted and took photos of each others' driving licenses. Aloysious also took down the number of the middle vehicle's driver. All drivers agreed to carry on with their own claiming from each of their insurances, and parted ways. Aloysious then drove the vehicle off the expressway, following the advice of EMAS crew on-site, to his girlfriend's place just off the expressway. He then called Skoda 24-hour hotline, and the vehicle was towed to Skoda.

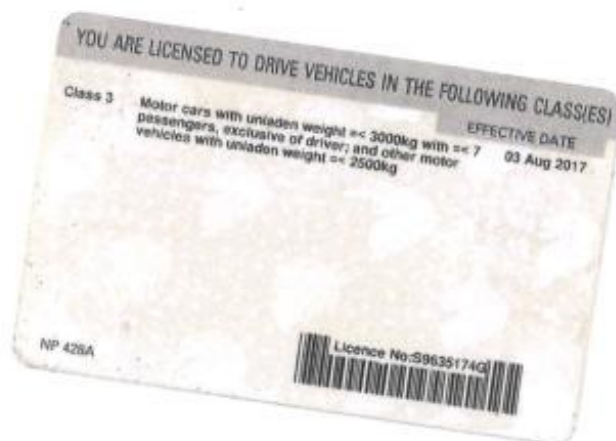

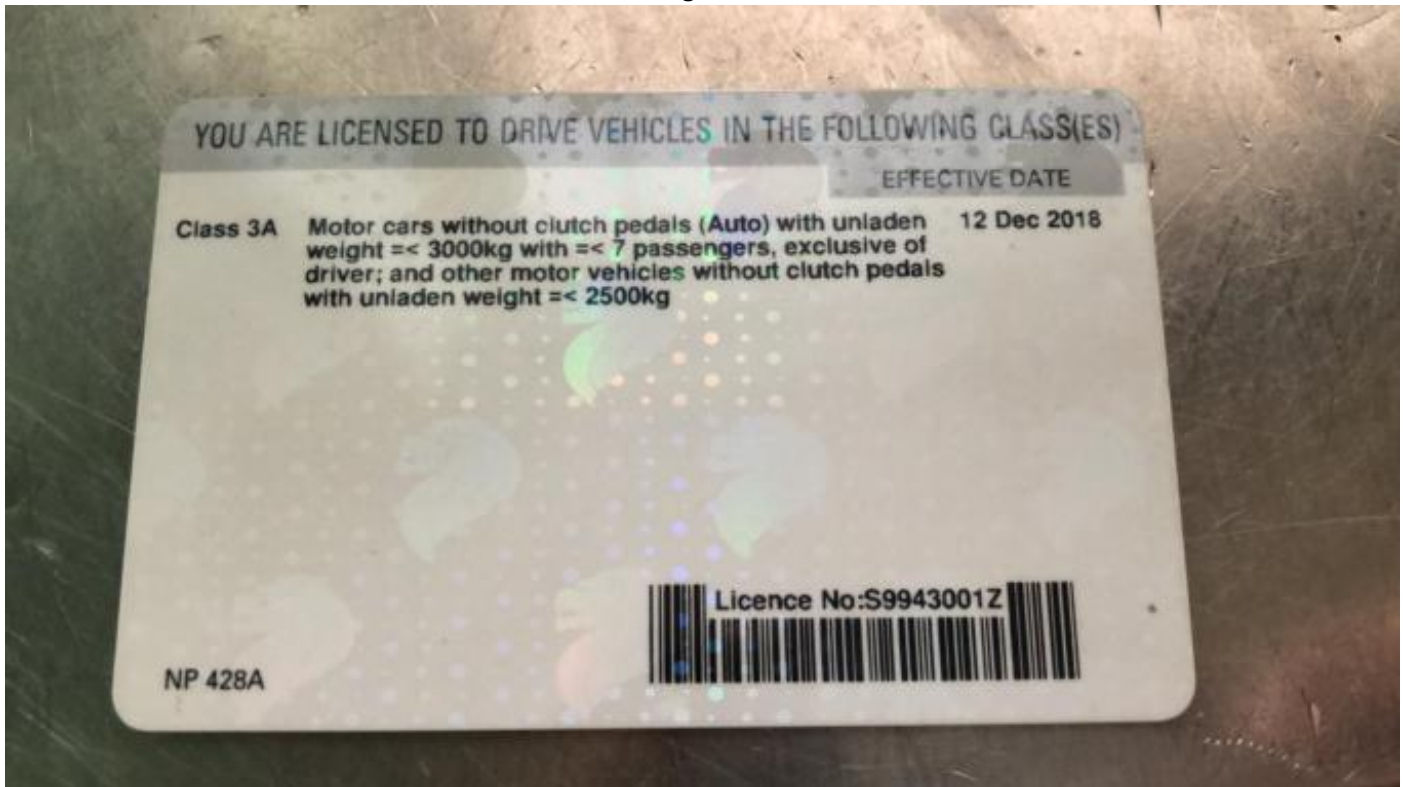

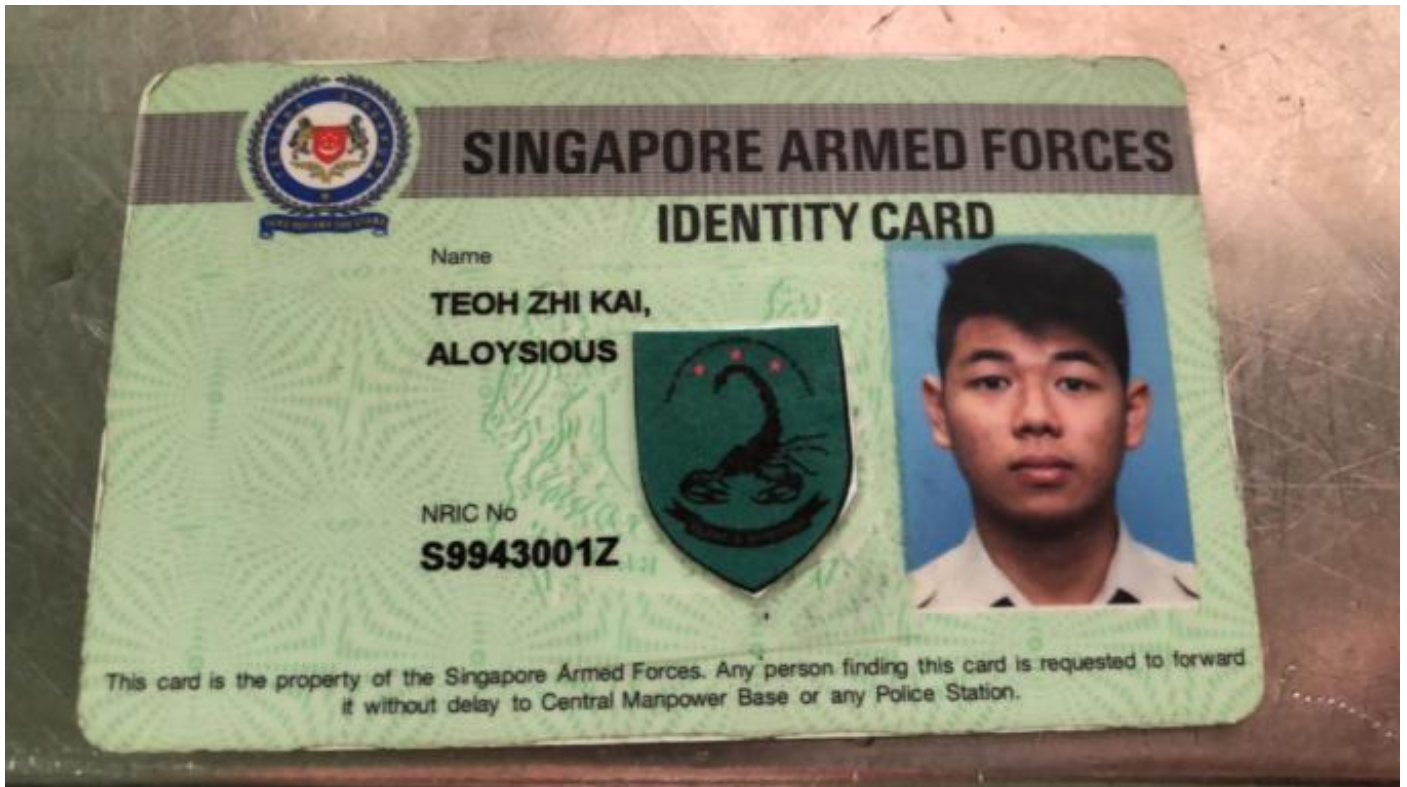
