

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

on 21 Oct 2020 at around 7:50pm to 8:00pm, I was driving at the most right lane of the expressway, PIE (towards Changi) before Jurong Town Hall Road Exit, my vehicle, SLT6548A was hit by another vehicle SLB1035R, Volvo brand coming from the middle lane. This happened as the driver was changing from the middle lane to the most right lane. His vehicle has hit my front left bumper, damaging the bumper side bracket, front bumper fog lamp, front bumper garnish, head lamp and front fender (all left side). As I was in the most right lane, there is no room for me to avoid and ~~the~~ my ~~car~~ car had scratches against the expressway railings on my car back right area. After the collision, the car (SLB1035R) did not stop to get out and continue to drive off. I followed the driver ~~to~~ until he stop at the most left lane of the expressway before Jurong Town Hall Road Exit. We get out of the vehicle and exchange our contact details and name and ~~we~~ we agree on a private settlement via whatsapp with him acknowledge. He told me to get a quote from my workshop and send it to him. Once I have sent the quote to him, he tell me to contact another party and did not want to pay me and also to report the accident.




